Inlight Student Mental Health Research – [2023 Research Fellowship Program](#). **Letter of intent due November 27, 2023, with full application due December 11, 2023.** This competition is open to graduate students conducting research projects focused on post-secondary student mental health and wellness. Value: \$10,000.



The [Lung Foundation's](#) Better Breathing Student Travel Award **application deadline is November 29, 2023.** Value: \$1,300 per project. Award recipient will be funded to attend Better Breathing Week 2024 and participate in a thesis competition. **Open to Graduate Students.**

The [Cancer Research Society](#) (Canada) has launched its operating grants competition. Value: \$65,000 per year for up to two years. **Letter of intent deadline is December 13, 2023. Full application deadline (invitation only) is February 13, 2024.** There are several targeted funding opportunities.

- Partnered with CIHR: Five grants for early career investigators; five grants for cancer survivorship research; and 10 grants for breast cancer research. A total of 20 projects will be co-funded in partnership with CIHR.

- Other partners: up to five projects for Breast cancer in Black women
- Cancer Research Society's Environment Cancer Fund and Read for the Cure: One project for environment cancer
- Partnered with Ovarian Cancer Canada: up to two projects for ovarian cancer
- Cancer Research Society Aristotle Fund: one project for gastroesophageal junction cancer
- Cancer Research Society Herbert James Davies Memorial fund: one project for multiple myeloma
- Lung cancer: up to two projects will be funded
- Cancer Research Society Charlotte Légaré Memorial Fund: up to two projects for pancreatic cancer
- Partnered with Susanne and Louis Daubois Fund: up to one project for prostate cancer.
- Other opportunities yet to be confirmed include funding for pediatric cancers.



**TRANSFORM HF Seed grant application deadline is December 18, 2023.** One \$70,000 grant is available, with potential to renew in year 2. The themes for 2023 are field-read point-of-care diagnostics; wearables and embedded sensors/ remote monitoring; data science innovation in heart failure prevention, treatment, or care; and digital health implementation. TRANSFORM HF is an interdisciplinary research network that focuses on heart failure care. Proposals must be co-led by two PIs, one of whom must be affiliated with U of T and/or TAHSN and the other with a university or academic health organization outside U of T/TAHSN.

**AMS** The [AMS Healthcare Fellowship in Compassion and Artificial Intelligence](#) is open to early and mid-career researchers. **Key dates: Letter of intent due January 11, 2024, with full application (by invitation) deadline TBD.** Value: \$75,000. The [AMS Healthcare Small Grant in Compassion and Artificial Intelligence](#) is valued at \$30,000. **Application deadline is February 7, 2024.**



The Social Sciences and Humanities Research Council [Storytellers competition](#) is now open to post-secondary students. **Application deadline is January 16, 2024.** Create a video or audio clip of up to three minutes or a text or infographic of up to 300 words featuring your own research or a teacher's (SSHRC funded research). Twenty applicants (considered the finalists) in phase 1 are eligible to receive \$3,000 in exchange for SSHRC's right to use their submission on SSHRC platforms. The 20 finalists will participate in an online workshop then present to the jury in phase 2 (travel and accommodation costs will not be covered). Five phase 2 submissions will be selected; these participants will receive an additional \$1,000. And then in the grand finale, the recipient of the engagement prize will receive \$1,000.



The [Canadian Gerontological Nursing Association](#) Research Grants and Scholarship Program is now open to association members. **Application deadline is January 19, 2024.** The Ann C. Beckingham Scholarship is available to RNs pursuing graduate education. The Research Grant offers up to \$2,500 for small grants – pilot studies that will lead to grant applications to larger funding agencies, or small studies focused on older adults and gerontological nursing. **PhD students should** talk to their supervisor and grants office if thinking of applying to this opportunity.



The Social Sciences and Humanities Research Council [Insight Development Grant](#) deadline is **February 2, 2024.** **U of T applicants will have an internal deadline** to meet for MRA (approx. Jan 29, 2024) and for full grant

## *New CIHR Opportunities*

Upcoming Opportunity: [Health System Impact Fellowship](#). **Anticipated launch: late fall 2023. Webinar: January 9, 2024, 12 – 1 pm. [Join here](#). Application deadline: Winter 2024**. This fellowship supports **PhD trainees, postdoctoral researchers**, and early career researchers in health services and policy research/related fields. More information about the application (from past competitions) [can be found here](#). Applicants must have a partner organization to embed with. Doctoral trainees receive a one year paid experiential learning opportunity; at least 60% of time is focused on a project of direct relevance to their partner organization. The 40% balance is protected for doctoral program commitments. Postdoctoral researchers receive a paid two-year experiential learning opportunity and are embedded with their health system partner organization for at least 70% of their time. The 30% balance is protected for academic research. The doctoral trainee stipend is \$45,000 with a \$5,000 professional development and research allowance; the postdoctoral researcher stipend is \$70,000 per year with a \$7,500 professional development training and research allowance.

Operating Grant: [Summer Program in Aging – Planning Grant](#). **Application deadline January 1, 2024**. This opportunity is to identify a host for the 2025 CIHR Institute of Aging Summer Program in Aging (SPA). The strategic topic area for 2025 is “Training a healthcare workforce to meet the needs of older adults”. Funds available: \$130,000, enough to fund one grant.

CIHR is partnering with the American Association for Cancer Research to co-[sponsor cancer survivor](#) and patient advocates from Canada to participate in the 2024 American Association for Cancer Research Scientist Survivor Program. **Application deadline is January 2, 2024**.

Team Grant: [Embracing diversity to achieve precision and health equity](#): **Letter of intent deadline February 1, 2024**, with full application due October 22, 2024. [Webinar: November 27, 2023, at 1 pm](#). There are two types of grants: Research Teams and Knowledge Mobilization Hub Supplements. There are several key elements including integration of EDI in research, diversity in study population to develop more precise approaches; interdisciplinary team-based approaches, engagement of people with lived/living experience; and more. There are **specific research areas** that will be funded, which include **Aging** (prevention, detection, and/or treatment of inflammatory aspects of high burden chronic diseases; underlying bio/social/structural/environmental determinants of health in disproportionately affected populations; self-determined health priorities of First Nations, Inuit and Metis re: infection and immunity); **Cancer** (increases understanding of heterogeneity in nutrition and metabolic health as they related to cancer prevention or early detection of cancer); **Indigenous** (self-determination/self-governance re: data sovereignty; reciprocity and quality of reciprocity and equal partnership between Indigenous and non-Indigenous approaches). Funds available: LOI: \$760,000 to fund 38 engagement grants at maximum of \$20,000 for up to one year. Full application stage: \$40,250,000 is available to fund approximately 19 Research Teams grants and one knowledge mobilization hub supplement. Partners include Diabetes Canada, the Kidney Foundation of Canada, Genome BC, and Genome Quebec.

[Spring Project Grant](#). **Registration deadline February 7, 2024, with full application due March 6, 2024** (U of T Applicants must submit an MRA approximately a week before deadline). **Important update: CIHR will no longer allow these attachments:** questionnaires, surveys, and consent forms; supplementary tables, charts, figures, and photographs; patient information sheets (for RCT applications); and publications. **If any of these documents are included, they will be removed.** Remember that the Project Grant is open to all areas of health research aligned with the CIRH mandate -including global health and commercialization. **Note that 4.6% of funding will be dedicated to supporting applications with an Indigenous health research focus.** In addition, the budget will be reserved so that the proportion of grants funded is at least equal to the proportion of applications submitted by ECRs, female applicants and French-language applications.

## Reminder – these competitions are still open

### *Canadian Opportunities*



**Heart & Stroke Canada** is funding new Research Networks of Excellence in Women's Heart and/or Brain Health. **Registration deadline is 4 pm eastern, November 30, 2023.** Full application (by invitation) is due April 18, 2024. Heart & Stroke plans to fund two networks; funding: \$1 million per year for a maximum of five years (total funding maximum \$10 million). Matching funds not required but cash / in-kind contributions strongly encouraged. There are two priority research areas: 1) risk factors; 2) diagnosis and treatment.



The Canadian Hemophilia Society – Novo Nordisk [psychosocial research program](#) **deadline is November 30, 2023.** This competition supports professionals and graduate students from the allied health disciplines to understand the psychosocial impact of hemophilia and other inherited bleeding disorders. Funds available: one \$20,000 grant.



The [Canadian Research Data Centre Network](#) offers an emerging scholars grant to support **PhD students** undertaking thesis-related research in a research data centre in Canada. Applications received from December 1 to March 31: grants will be awarded by May 15. Applications received from April 1 to July 31: grants will be awarded by September 15. **Applications received from August 1 to November 30: grants will be awarded by January 15.**

**Connaught** The [Connaught New Researcher Competition](#) is now open for U of T appointed faculty who are within five years of their tenure stream appointment and ten years of having completed a PhD or equivalent. **The deadline is December 1, 2023.** Funds available: up to \$25,000.





[Parkinson Canada's](#) research grant program is now open. **Application deadline is December 5, 2023, for all competitions.** Parkinson Canada has earmarked \$200,000 for projects that use datasets and resources from Canadian Open Parkinson Network – these funds are open to all applicants from the general research competition. The Canadian Open Parkinson Network has enrolled over 1500 Parkinson's patients who are available as research participants (e.g., demographic, epidemiological and clinical information, and biological samples).

SSHRC, Canadian heritage, Genome Canada and UKRI-AHRC have partnered on this grant. Funds available: \$30,000.



[Public Health Agency of Canada and SSHRC Partnership Engage](#) joint initiative: “Advancing socio-economic research for evidence-informed public health decision-making.” Objectives include – supporting evidence-informed public health policy making; addressing horizontal public health policy needs; broadening understanding of socio-economic impacts of public health interventions; and examining issues related to data sources, gaps and potential remedial strategies. Funds available: \$7,000 to \$25,000 for up to one year. **Application deadline December 15, 2023.** U of T applicants must submit MRA by noon, December 7, 2023, and full application on the online form by 9 am, December 13, 2023.

The opportunity is open to PhD students and Professors. Junior researchers may apply for an additional scholarship to cover travel and local expenses. Proposals are also being accepted for multidisciplinary workshops on ethical, legal and social implications of new medical developments. **Application deadline for both is December 6, 2023.**



[Alex's Lemonade Stand Foundation](#) Young Investigator Grant **application deadline is December 11, 2023.** Funds available: \$60,000 per year in direct costs for up to three years. Applicants must have received MD/PhD, within past seven years. A mentor is required.

## *CIHR Grant Opportunities*

[Summer Program in Aging](#) – **PhD student opportunity** – students must be enrolled at a Canadian university. **Application deadline December 7, 2023.** This year’s theme is “Ageism in Health Research, Delivery, and Outcomes in Older Adults.” This event will be held in Vancouver, BC, June 2-7, 2024. Trainees must attend all sessions and networking events. The maximum amount for a single award is \$1,500 and covers transport; ground transport to and from airport to conference location.

**Ongoing until March 5, 2024:** [Patient-Oriented Research Awards – Transition to Leadership Stream – Phase 2.](#) Recipients of the POR Transition to Leadership Stream – Phase 1 awards should review application deadlines carefully. CIHR anticipates funding a maximum of 22 awards over this program’s duration. Maximum award is \$115,000 per year for up to three or four years depending on the applicant’s Phase 1 status. Partner contributions required to match CIHR contribution at minimum of 1:1 ratio.

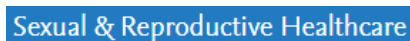
