**crohn's  colitis** The [Crohn's and Colitis Foundation of Canada](#) is offering multiple funding opportunities: The IBD Nurse fellowship (mentorship with an IBD nurse) with \$2,500 for mentee and mentor (contingent on funding) due **July 12, 2024**; the IBD Nursing educational travel awards (up to six, \$2,000 each) due **July 19, 2024**; and the nursing-led IBD Research Grant, **due August 30, 2024**, with a value of up to \$15,000.



The University of Toronto [Data Sciences Institute Catalyst Grant](#) **letter of intent deadline is July 12, 2024**. There are two tiers: Tier 1: up to \$100,000 for 1-2 years; Tier 2, \$50,000 for 1-2 years. Tier 1 focuses on novel statistical or computational tools; Tier 2 focuses on projects that foster robust exchange of knowledge in areas where there is unmet need for new data science methods.



The [SSHRC postdoctoral fellowship competition](#) **deadline is September 12, 2024**. Value: \$70,000 per year for up to two years.

The [2025 IDRC Research Awards competition](#) is now open. **Application deadline is September 22, 2024.** The themes include ethics in development research, global health, policy and evaluation, and more. All awards are based in Ottawa, except for climate-resilient food systems (Nairobi) and democratic and inclusive governance (New Delhi).

### *New CIHR Opportunities*

[Planning and Dissemination grants](#). **Application deadline is August 6, 2024.** All CIHR institutes are participating in this opportunity. Funding amounts vary by institute, and some awards are reserved for early career researchers. Applications must address all criteria to meet the threshold of excellence; those that do so will qualify for the randomization process. CIHR is using a particle randomization approach to fund applications for each institute. Funds available: \$2,102 260, enough to fund approximately 81 grants. This amount is broken down by institutes; individual grant values vary from \$10,000 to \$50,000, depending on the institute.

Catalyst Grant: [Moving Upstream: Structural Determinants of Health](#). **Registration deadline September 11, 2024, with full application due October 9, 2024.** Objectives: to increase evidence base on structural determinants of health inequities in Canada; support novel designs, theories, methods to understand structural determinants of health and impact on health inequities; to foster connections and collaborations. Research areas include structural determinants of health inequities: commerce; racism and health; ageism, cancer; sex, gender and health; human development, child and youth health; indigenous health and wellness; and more. Total funding available: \$4,000,000, enough to fund approximately 32 grants. Maximum per grant: \$125,000 per year for one year

The Greenwall Foundation [Bridging Bioethics Research & Policymaking](#) **application deadline is July 22, 2024.**



The March of Dimes (US) [Discovery Research Grants](#) **application deadline is September 6, 2024.** The focus is on maternal fetal health and related fields. Areas of interest include racial inequities as they relate to morbidity, mortality, and access to care, and cardiovascular health conditions developed during or exacerbated during pregnancy. Funds available: \$200,000 over two years inclusive of 10% indirect costs.

## Competitions with no fixed deadline



[NSERC and Mitacs](#) have developed a joint application process for researchers seeking support from both agencies. It is now possible to request support through Mitacs Accelerate internships as part of the full Alliance application. The [Alliance](#) grants system accepts applications at any time – there is no deadline.



NSERC Alliance Grants. **Application deadline: No fixed date.** There are two streams: Alliance [Advantage](#): \$20,000 to \$1 million per year for 1-5 years, university researchers collaborate with external organizations to meet partner goals. Alliance [Society](#): \$20,000-\$1 million per year for 1-5 years; university researchers collaborate with partners on projects with societal impact.



[Mitacs Accelerate](#) accepts applications throughout the year. The competition is open to doctoral students and post-doctoral fellows. Students partner with a supervising professor and a partner organization to develop a research project. Partner funding is required. Funding begins at \$15,000 for 8 months.



[Mitacs Elevate](#) accepts proposals all year round. This is a postdoctoral fellowship with a professional development curriculum component. Value: minimum \$55,000 stipend (partner contributes \$30,000 per year).



[FOR CANCER RESEARCH](#) The [Gateway Foundation for Cancer Research](#) accepts grants from researchers around the world on a rolling basis. Successful grant applications are typically funded within 3 to 4 months. A letter of intent is required, and if accepted, applicants have roughly four weeks to submit the full application.



Foundation The [Rising Tide Foundation for Clinical Cancer Research](#) (Switzerland) accepts letters of intent year-round. Note – matching cash funds are required. Check for eligibility by emailing [grants@risingtide-foundation.org](mailto:grants@risingtide-foundation.org) before beginning an application.



The [Mayday Fund](#) offers grants for research into pain. **There is no deadline; grants are reviewed at the next Trustee's meeting.**



[Max Bell Foundation](#) has an ongoing review of grant applications in health and wellness. An LOI is required, and full application is by invitation.



The [R. Howard Webster Foundation](#) (Canada) offers funding in the broad areas of Arts & Culture, Education, Environment, Medical, and Social Services. There are no specific deadlines, and once submitted, review and decision process may take 6 months.



[CANSSI Ontario](#) offers grants of up to \$5,000 to cover costs associated with accessing and working with large data sources. Canssi also offers two grants of up to \$10,000 each to support projects using ICES data. **Applications are accepted on a rolling basis** until two grants have been funded in a given academic year. **Trainees or faculty members** at Ontario-based universities are eligible to apply. Each proposal must include two faculty members from different academic units (at least one from a stats/biostats department). CANSSI also offers funds (\$500-\$1,000) to support Ontario workshop/lecture programs in emerging areas of statistical and data sciences.



The [Thrasher Foundation](#) in the US supports children's medical research. *E.I. Thrasher awards* focus on changing pediatric clinical care. **Concept submission deadlines are January 18 and July 16.** Funds available: grants are not awarded over \$550,000; grant duration: up to three years. Indirect costs of no more than 7% of direct costs are allowed. *Early Career awards* focus on development of researchers in child health. The competition is open to physicians or **post-doctoral researchers**. **Concept submission deadlines: March 19, 2024, and September 5, 2024.** Maximum funding: \$25,000 in direct costs, for up to two years; indirect costs of no more than 7% of direct costs are allowed. Up to \$12,500 in total may be used for salary of the new researcher.

The [Chronic Pain Centre of Excellence for Canadian Veterans](#) funding competition is open. Funds available: maximum of \$450,000 per grant. There are three opportunities: assessing and improving quality of life of Canadian veterans living with chronic pain and common comorbidities; health system and policy innovations for Canadian veterans living with chronic pain; and understanding the diverse experiences of Canadian veterans living with chronic pain. **Application deadline is June 30, 2024.**

The [Terry Fox New Frontiers Program Grants](#) – Breaking new frontiers in cancer research through innovative team science – is now open. There will be an information webinar on May 16, 2024, 4-5 pm EST. The webinar will be recorded and made available. **Letter of intent deadline is Monday, July 8, 2024, at 5 pm PDT. Catalyst Grant: [Community-based research in climate change priority areas](#). **Registration deadline is August 14, 2024, with full application due September 12, 2024.** This funding opportunity will focus on climate justice, alternative diagnoses of Lyme disease, food security in northern communities, and health impacts of climate change on older adults. Funds available: \$1,625,000. Of this, \$250,000 is available to fund up to two applications relevant to the health impacts of climate change on older adults pool. Maximum per grant: \$125,000 per year for up to one year.

Operating Grant: [ECRs in Human Development, Child and Youth Health](#). **Registration deadline September 4, 2024, with full application due September 24, 2024.** Funds available: \$1,800,000, enough to fund approximately 12 grants. Maximum per grant is \$50,000 per year for up to three years. 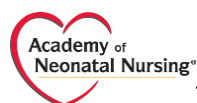
