### *New Canadian Opportunities*



The Public Health Agency of Canada's [Dementia Community Investment](#) Call for Letter of Intent **deadline is July 24, 2024, at 14:59 pm. Full application by invitation only.** This program funds projects to optimize health and wellbeing of people living with dementia and family/friend caregivers; and increase knowledge of dementia and risk and protective factors. Projects must be evidence-based and community-based. Funded projects are not permitted to provide services and supports that are the responsibility of other jurisdictions (e.g., respite care, primary care, hospital care, long-term care, and training of health care providers) but may link with health care providers as appropriate. There are two streams: Emerging (up to 4 fiscal years, up to \$250,000 per fiscal year for a maximum of \$1,000,000) and Advanced (up to two years, up to \$400,000 per year, maximum \$800,000).

**Alzheimer Society** The [Alzheimer's Society of Canada](#) **Proof of Concept Letter of Intent deadline is Wednesday July 24, 2024, at 5 pm.** Full application (by invitation) is Monday, September 9, 2024, at 8 am. Value: \$100,000 maximum over three years. This grant funds innovative, high-risk and high-reward research.

**Breast Cancer Canada** Breast Cancer Canada has partnered with AstraZeneca Canada to offer two collaborative grants on advancing research in new concepts [to improve equity of uptake, experience and outcomes](#) from neoadjuvant therapy in early breast cancer. **Submission deadline is August 2, 2024.** Value: \$100,000.



[Cystic Fibrosis Canada](#) research competition is now open. **Letter of intent deadline for clinical and research grants as well as early career investigator awards is August 15, 2024, with full application due October 1, 2024. Deadline for Seed grants is September 3, 2024.**

All awards are based in Ottawa, except for climate-resilient food systems (Nairobi) and democratic and inclusive governance (New Delhi).

Funding amounts vary by institute, and some awards are reserved for early career researchers. Applications must address all criteria to meet the threshold of excellence; those that do so will qualify for the randomization process. CIHR is using a particle randomization approach to fund applications for each institute. Funds available: \$2,102 260, enough to fund approximately 81 grants. This amount is broken down by institutes; individual grant values vary from \$10,000 to \$50,000, depending on the institute.

Catalyst Grant: [Community-based research in climate change priority areas.](#) **Registration deadline is August 14, 2024, with full application due September 12, 2024.** This funding opportunity will focus on climate justice, alternative diagnoses of Lyme disease, food security in northern communities, and health impacts of climate change on older adults. Funds available: \$1,625,000. Of this, \$250,000 is available to fund up to two applications relevant to the health impacts of climate change on older adults pool. Maximum per grant: \$125,000 per year for up to one year.

Operating Grant: [ECRs in Human Development, Child and Youth Health.](#) **Registration deadline September 4, 2024, with full application due September 24, 2024.** Funds available: \$1,800,000, enough to fund approximately 12 grants. Maximum per grant is \$50,000 per year for up to three years. Two grants will be funded from the Indigenous Human Development, Child and Youth Health pool, and two applications will be funded from the Human Development, Child and Youth Health for Equity-Deserving Groups pool.

Total funding available: \$4,000,000, enough to fund approximately 32 grants. Maximum per grant: \$125,000 per year for one year

[Implementation Science Chairs in Human Development, Child and Youth Health](#). The objectives are to build capacity; advance the field; and strengthen research excellence and ensure maximum research impact. Funds available: \$4,000,000, enough to fund up to four awards; maximum per award is \$200,000 per year for up to five years for a total of \$1,000,000 per award. **Application deadline: October 15, 2024.** Eligibility: early or mid-career researcher.

[Team Grant: Healthy Youth](#). **Registration deadline December 10, 2024. Full application due February 2, 2025.** This grant will support research teams that bring evidence to at least two of the six youth-defined priorities of Canada's Youth Policy, of which Health and Wellness is one. Teams must follow key design elements as appropriate – tri-partite leadership; youth engagement; intersectoral and multi-disciplinary teams; EDI and Indigenous rights; building and/or bridging capacity; and knowledge mobilization. Funds available: \$9,000,000, enough to fund approximately six grants. Funding per grant: \$300,000 per year for up to 5 years for a total of \$1,500,000 per grant.
