[Lung Health Foundation Canada](#) **Better Breathing Rapid Fire Thesis Competition application deadline is October 6, 2024.** **This competition give students** the chance to have their travel expenses for the Better Breathing Week Conference (January 2025) to be reimbursed.



Diabetes Canada’s [Research Collaboration Support Grant](#) **deadline is October 10, 2024.** Funds available: \$3,000 to \$20,000. This grant supports researcher-led activities that foster sharing of ideas and development of new knowledge and solutions via for example meetings, networking events, training sessions, lecture series.



[Inlight Student Mental Health Fellowship](#) **program notice of intent deadline is October 7, 2024, with full application due October 15, 2024. A webinar will be held September 20, 2024, at 12 noon.** This opportunity is open to PhD and DN students. Value: \$5,000.

Student opportunity: the [Ontario Drug Policy Research Network](#) is a collaboration between researchers and drug policy decision-makers across Ontario, which offers a student training program. Drug Policy Research 101: Student Training Program is a one-year collaborative opportunity with networking and presenting opportunities. Application **deadline is October 29, 2024; program starts January 2, 2025.**



The [Leukemia and Lymphoma Society's Operating Grant](#) **letter of intent deadline is November 6, 2024, with full application due (by invitation) February 5, 2025.** Value: \$100,000 per year for up to two years. LLSC is also partnering with AstraZeneca to fund two grants in this competition and with Myeloma Canada to fund one grant in this competition. The [Blood Cancer Quality of Life Grant](#) **Letter of intent deadline is also November 6, 2024.** Funds available: \$75,000 per year for two years (to a maximum of \$150,000 for two years). **Full application by invitation is due January 92, 2025.** Topics of interest include interventions to address fear of recurrence, interventions of the emotional effects of cancer, development of quality of life measures specific to blood cancers, and more.



The [U of T Data Sciences Institute](#) is calling for supervisors for its 2025 Summer Undergraduate Data Science Opportunities Program. **Deadline is November 15, 2024.** The Institute will provide \$7,200 to the supervisor for the student. Anything above is covered by the supervisor.



The [Canadian Hemophilia Society Novo Nordisk Psychosocial Research Program](#) **application deadline is November 29, 2024.** Funding: One or two research grants will be awarded to a maximum of \$40,000 for one year.



Social Sciences and Humanities Research Council: [Partnership Development Grant](#). **Application deadline November 15, 2024.** Value: \$75,000 - \$200,000, for 1-3 years. University of Toronto Researchers must submit their grants approximately 5 days ahead of sponsor deadline. [Knowledge Synthesis Grant](#) – Envisioning Governance Systems that work. **Application deadline: December 12, 2024;** University of Toronto researchers must submit their grant 5 days ahead of sponsor deadline. Value: \$30,000 for one year.



The [Kids Brain Health Network](#) supports research for children with neurodevelopmental disabilities and their families across Canada. There are two programs accepting applications: Innovation and Implementation. **Both have application deadlines of December 16, 2024; both require 1:1 partner matching of KBHN funding.** Innovation: up to \$100,000 per year for up to two years. The focus is on new projects that show strong near-term potential for implementation or commercialization readiness. Implementation: up to \$200,000 per year for up to two years from KBHM. Focus is on large-scale implementation projects bridging the gap between scientific innovation to national uptake.

[Alex's Lemonade Foundation Innovation Grant](#) (childhood cancer research) **letter of intent deadline is October 16, 2024, with full application by invitation only.**



[STTI American Association of Critical Care Nurses Grant](#) **application deadline is October 27, 2024.** University of Toronto PhD or DN students planning to apply to this grant should speak to their supervisor and the research office about eligibility.

Competitions with no fixed deadline



[NSERC and Mitacs](#) have developed a joint application process for researchers seeking support from both agencies. It is now possible to request support through Mitacs Accelerate internships as part of the full Alliance application. The [Alliance](#) grants system accepts applications at any time – there is no deadline.



NSERC Alliance Grants. **Application deadline: No fixed date.** There are two streams: Alliance [Advantage](#): \$20,000 to \$1 million per year for 1-5 years, university researchers collaborate with external organizations to meet partner goals. Alliance [Society](#): \$20,000-\$1 million per year for 1-5 years; university researchers collaborate with partners on projects with societal impact.



[Mitacs Accelerate](#) accepts applications throughout the year. The competition is open to doctoral students and post-doctoral fellows. Students partner with a supervising professor and a partner organization to develop a research project. Partner funding is required. Funding begins at \$15,000 for 8 months.



[Mitacs Elevate](#) accepts proposals all year round. This is a postdoctoral fellowship with a professional development curriculum component. Value: minimum \$55,000 stipend (partner contributes \$30,000 per year).



FOR CANCER RESEARCH The [Gateway Foundation for Cancer Research](#) accepts grants from researchers around the world on a rolling basis. Successful grant applications are typically funded within 3 to 4 months. A letter of intent is required, and if accepted, applicants have roughly four weeks to submit the full application.



Foundation The [Rising Tide Foundation for Clinical Cancer Research](#) (Switzerland) accepts letters of intent year-round. Note – matching cash funds are required. Check for eligibility by emailing grants@risingtide-foundation.org before beginning an application.



The [Mayday Fund](#) offers grants for research into pain. **There is no deadline; grants are reviewed at the next Trustee's meeting.**

Max Bell Foundation

[Max Bell Foundation](#) has an ongoing review of grant applications in health and wellness. An LOI is required, and full application is by invitation.



The [R. Howard Webster Foundation](#) (Canada) offers funding in the broad areas of Arts & Culture, Education, Environment, Medical, and Social Services. There are no specific deadlines, and once submitted, review and decision process may take up to 6 months.



[CANSSI Ontario](#) offers grants of up to \$5,000 to cover covers associated with accessing and working with large data sources. Canssi also offers two grants of up to \$10,000 each to support projects using ICES data. **Applications are accepted on a rolling basis** until two grants have been funded in a given academic year. **Trainees or faculty members** at Ontario-based universities are eligible to apply. Each proposal must include two faculty members from different academic units (at least one from a stats/biostatistics department). CANSSI also offers funds (\$500-\$1,000) to support Ontario workshop/lecture programs in emerging areas of statistical and data sciences.



The [Thrasher Foundation](#) in the US supports children's medical research. [E.I. Thrasher awards](#) focus on changing pediatric clinical care. **Concept submission deadlines are January 14, 2025, and July 15, 2025.** Funds available: grants are not awarded over \$550,000; grant duration: up to three years. Indirect costs of no more than 7% of direct costs are allowed. [Early Career awards](#) focus on development of researchers in child health. The competition is open to physicians or **post-doctoral researchers**. **Concept submission deadlines: March 18, 2025.** Maximum funding: \$25,000 in direct costs, for up to two years; indirect costs of no more than 7% of direct costs are allowed. Up to \$12,500 in total may be used for salary of the new researcher.

[British Heart Foundation](#) **Upcoming opportunity:** CIHR will be supporting the British Heart Foundation's International Research Challenge on Women's Cardiovascular Health – supported by the Global Cardiovascular Research Funders Forum. **This opportunity will launch on September 25, 2024.** Two stages: Letter of intent and Full application (invitation only).

The [Winter 2025 Planning and Dissemination Grant](#) **competition application deadline is November 19, 2024.** Funds are available for planning (working to identify research questions, emerging issues; discussion of a research project; pretty much any work leading to a research grant proposal) or dissemination activities (education of groups, knowledge dissemination, dissemination and/or discussion of research findings, development and dissemination of knowledge translation products and tools). Funds available vary, usually between \$10,000 and \$50,000. Most CIHR institutes are offering funding. U of T trainees are not eligible to apply.

The [Summer Program in Aging](#) (SPA) is a 5-day capacity-building program for graduate trainees. **Application deadline is November 26, 2024.** The focus this year is Training a healthcare workforce to meet the needs of older adults. SPA will be hosted at Baycrest Academy for Research and Education in Toronto, ON, June 8-13,

2025. Funding is available for travel expenses. Approximately 40 awards will be made – 20 to postdoctoral trainees; 15 to doctoral trainees; and 5 to masters trainees.

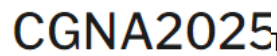
