### *New Canadian Opportunities*



The [University of Toronto's SDGs@UofT Students Awards Program](#) **application deadline is October 21, 2024.**

This competition is open to **graduate students** (e.g., PhD students) enrolled in full-time programs and working with an SDGs Scholars Academy Fellow or affiliate on a project that aligns one of the SDG research themes. Successful applicants receive \$1,500 (one-time) for 12 months and can re-apply in subsequent years. Nursing is one of the eligible academic units.



The [Canadian Pain Society Trainee Research Awards](#) **application deadline is October 31, 2024.** These awards (**trainee award and equity trainee research award**) are each valued at \$2,000 to support dissertation costs; recipients also receive complimentary registration to the 2025 scientific meeting.



The University of Toronto's **Institutional Strategic Initiatives Office** is launching a new, competitive, two-stage [Institutional Strategic Initiatives Funding Program](#) valued at up to **\$150,000**. Funding will support cross-divisional and interdisciplinary research initiatives that have the potential to impact issues of great societal importance. **Deadline: November 1, 2024** (full application). Competition open to University of Toronto researchers only.



The [Emerging Pandemics and Infections Consortium Doctoral Awards](#) application deadline is **November 8, 2024**. Applicants must have achieved candidacy and be supervised by a faculty member with a primary affiliation at the University of Toronto or one of EPIC's partner hospitals. Value: \$10,000 for one year.



The Data Sciences Institute is offering two grants, both with a deadline of November 15, 2024. [Critical investigation of data science](#) (up to \$10,000 for up to 12 months) will provide seed funding for projects ranging from articulation of potential harms in existing datasets and data science more broadly. [Computational and quantitative social sciences grant](#) (up to \$10,000 for up to 12 months) will support funding for projects applying data science methods to uncover new findings relevant to social scientists.



The [Ontario Women's Health Scholars Award](#) has launched. These awards are available to **doctoral, master's and postdoctoral students. Anticipated internal deadline is November 29, 2024**. Students must check with their academic department for exact deadlines. This competition is open to Canadian citizens or permanent residents. SDGs@UofT has launched [Catalyst and Synthesis Grants](#). Value: Up to \$20,000 for 1-2 years. **Full application deadline December 3, 2024**. Catalyst grants should be used to develop and/or evaluate SDG initiatives while Synthesis grants will produce scoping, systematic or literature reviews.



The [Canadian Women's Heart Health Centre](#) has launched its awards program, including a trainee award (nominations open November 1, 2024; the **deadline is January 9, 2025**); a heart, brain and vascular health investigator award for senior and ECR investigators (nominations open November 1, 2024; the **deadline is January 31, 2025**)



[SSHRC Insight Development Grants](#) (IDGs) **have an application deadline of February 2, 2025**. U of T applicants must meet internal deadlines and submit their full application approximately 1 week ahead of sponsor deadline. Value: \$7,000 to \$75,000 for 1-2 years. IDGs support research in early stages for emerging (within six years of completion of first doctorate) and established scholars (exploring new research questions and/or approaches distinct from previous/ongoing research).

[Greenwall Foundation Open-Access Publication Funding](#) will support open-access fees for publications resulting from Greenwall-funded work. Application deadline: funds will be awarded on a first-come, first-served basis until December 1, 2024, or until funding is depleted (whichever comes first).



The [Horowitz Foundation for Social Policy Award](#) (US\$10,000) is open to **doctoral** students. **Application deadline is December 1, 2024.**



[Sigma Theta Tau International Research Grants](#) with a **December 1, 2024, application deadline** include small grants, the Alpha Eta collaborative Research Grant, the Canadian Nurses Foundation Collaborative Grant, the Council for the Advancement of Nursing Science Grant, the rosemary Berkel Crisp Research Award, and the Western institute of Nursing Research Grant. The [Margaret McNamara Education Grants US-Canada program](#) is **accepting applications between now and January 15, 2025.** This competition is open to **doctoral students** – those who self-identify as ‘woman’, are at least 25 years old at time of application deadline, are registered at an accredited in-person academic institution and program, and a citizen from the [eligible country list](#). It is not open to Canadian citizens or those with Canadian landed immigrant status. Value: Up to US\$15,000.



The [International Association of Medical Science Educators](#) **grants application deadline is January 15, 2025.** There are two arms: Educational Scholarship grants and Curriculum Innovation Grants. Value: Up to \$5,000. The [IAMSE-ScholarRX Educational Research Grant Program for students](#) **deadline is also January 15, 2025.** Value: four student grants will be awarded for up to \$2,500. PhD students at U of T should consult with their supervisor to determine eligibility and relevance.

**Upcoming opportunity:** CIHR will be supporting the British Heart Foundation's International Research Challenge on Women's Cardiovascular Health – supported by the Global Cardiovascular Research Funders Forum. **One grant of USD \$10 million over 5 years will be awarded. Letter of intent deadline is January 15, 2025. Full application by invitation only.**

Team Grant: [Canadian Consortium on Neurodegeneration in Aging \(CCNA\) Phase III:](#) Research Teams. Funds available: \$250,000 per year for up to four years. Themes: primary prevention; secondary prevention and treatment; quality of life. **Registration deadline: November 6, 2024; full application due December 11, 2024.**

The [Winter 2025 Planning and Dissemination Grant](#) **competition application deadline is November 19, 2024.** Funds are available for planning (working to identify research questions, emerging issues; discussion of a research project; pretty much any work leading to a research grant proposal) or dissemination activities. Funds available vary, usually between \$10,000 and \$50,000. Most CIHR institutes are offering funding. U of T trainees are not eligible to apply.

The [Summer Program in Aging](#) (SPA) is a 5-day capacity-building program for graduate trainees. **Application deadline is November 26, 2024.** The focus this year is Training a healthcare workforce to meet the needs of older adults. SPA will be hosted at Baycrest Academy for Research and Education in Toronto, ON, June 8-13, 2025. Funding is available for travel expenses. Approximately 40 awards will be made – 20 to postdoctoral trainees; **15 to doctoral trainees**; and 5 to masters trainees.

**Catalyst grant: Digital Health.** **Application deadline December 3, 2024.** Value: \$100,000 per year for one year; up to four grants will be funded: one will fund research relevant to the Indigenous Health research funding pool; three to the early to mid-career research funding pool.

[Team Grant: Healthy Youth](#). **Registration deadline December 10, 2024. Full application due February 2, 2025.** This grant will support research teams that bring evidence to at least two of the six youth-defined priorities of Canada's Youth Policy, of which Health and Wellness is one. Funds available: \$9,000,000, enough to fund approximately six grants. Funding per grant: \$300,000 per year for up to 5 years for a total of \$1,500,000 per grant.
