## New Canadian Opportunities

AMS Small Grant in compassion and artificial intelligence application deadline is February 19, 2025. Value: \$30,000. AMS Project Grant, for research projects in the history of healthcare and allied disciplines (science and technology studies, etc.). projects must advance the history of health, healthcare and disease, or the education of health professionals. Value: \$20,000. Application deadline April 2, 2025. AMS Postdoctoral Fellowship supporting study, analysis and interpretation of past practices, philosophies and/or epistemologies related to human health, healthcare and/or disease or the education of health professionals. Value: \$70,000, plus a \$2,500 research and travel allowance. Application deadline April 2, 2025.



The Edwin S.H. Leong Community Engagement and Knowledge Mobilization Grant application deadline is February 7, 2025. Value: \$10,000. This supports engaging community partners to identify research priorities, co-design research projects, and develop knowledge mobilization initiatives within the field of child health research.

National Collaborating Centre

for Methods and Tools The <u>National Collaborating Centre for Methods and Tools Knowledge</u> <u>Translation</u> Graduate Student Awards application deadline is February 10, 2025. Value: \$1,500. This award is open to graduate students (currently enrolled PhD students or PhD students who have completed a Canadian graduate degree in the last 12 months, enrolled in a discipline relevant to public health – broadly defined) regarding their work on knowledge translation in public health.



The Social Sciences and Humanities Research Council <u>Partnership Engage Grant</u> deadline is March 15, 2025. U of T applicants must meet internal deadlines and submit approximately 5 days ahead of deadline. Value: \$7,000 to \$25,000. PEGs provide support for partnered research with a single partner organization from public, private or not-for-profit sector.

**Connaught Fund** The <u>Connaught Community Partnership Research Program</u> letter of intent deadline is March 17, 2025, with full application due May 1, 2025. Value: Up to \$50,000 per year for one or two years.

### Canadian Lung Association

B R E A T H E The <u>Canadian Lung Association (Breathe)</u> 2025 Allied Health Fellowship Awards and Research Grants **registration deadline is March 19, 2025, with full application due April 9, 2025.** Fellowship (PhD students) award: \$5,000 with matching funds from supervisor of \$5,000. Research Grant: \$10,000 with matching \$10,000 from the Principal Investigator.

- Research on current topics in Alzheimer's disease and its related dementias. Two opportunities: <u>PAR-25-332</u> Expires November 6, 2027; and <u>PAR-25-331</u> Expires November 17, 2027
- Ethical, legal and social implications research. Three opportunities: <u>PAR-25-371</u> Expires November 19, 2026; <u>PAR-25-370</u> Expires November 17, 2026; <u>PAR-25-369</u> Expires November 19, 2026.
- Innovative pilot mental health services research not involving clinical trials. Two opportunities: <u>PAR-25-284</u> and <u>PAR-25-283</u> both expire January 8, 2028, LOI required 30 days before submission for both.

## Competitions with no fixed deadline



NSERC and Mitacs have developed a joint application process for researchers seeking support from both agencies. It is now possible to request support through Mitacs Accelerate internships as part of the full Alliance application.



NSERC Alliance Grants. **Application deadline: No fixed date.** There are two streams: Alliance <u>Advantage</u>: \$20,000 to \$1 million per year for 1-5 years, university researchers collaborate with external organizations to meet partner goals. Alliance <u>Society</u>: \$20,000-\$1 million per year for 1-5 years; university researchers collaborate with partners on projects with societal impact.

**Mitacs** Accelerate accepts applications throughout the year. The competition is open to doctoral students and postdoctoral fellows. Students partner with a supervising professor and a partner organization to develop a research project. Partner funding is required. Funding begins at \$15,000 for 8 months.

**Mitacs Elevate** accepts proposals all year round. This is a postdoctoral fellowship with a professional development curriculum component. Value: minimum \$55,000 stipend (partner contributes \$30,000 per year).

# GATEWAY

FOR CANCER RESEARCH The <u>Gateway Foundation for Cancer Research</u> accepts grants from researchers around the world on a rolling basis. Successful grant applications are typically funded within 3 to 4 months. A letter of intent is required, and if accepted, applicants have roughly four weeks to submit the full application.

## RISING TIDE

Foundation The <u>Rising Tide Foundation for Clinical Cancer Research</u> (Switzerland) accepts letters of intent year-round. Note – matching cash funds are required. Check for eligibility by emailing <u>grants@risingtide-foundation.org</u> before beginning an application.

## MAYDAY

The <u>Mayday Fund</u> offers grants for research into pain. There is no deadline; grants are reviewed at the next Trustee's meeting.

Max Bell Foundation Max Bell Foundation has an ongoing review of grant applications in health and wellness. An LOI is required, and full application is by invitation.



The <u>R. Howard Webster Foundation</u> (Canada) offers funding in the broad areas of Arts & Culture, Education, Environment, Medical, and Social Services. There are no specific deadlines, and once submitted, review and decision process may take up to 6 months.



**CANSSI Ontario** offers grants of up to \$5,000 to cover covers associated with accessing and working with large data sources. Canssi also offers two grants of up to \$10,000 each to support projects using ICES data. **Applications are accepted on a rolling basis** until two grants have been funded in a given academic year. **Trainees or faculty members** at Ontario-based universities are eligible to apply. Each proposal must include two faculty members from different academic units (at least one from a stats/biostats department). CANSSI also offers funds (\$500-\$1,000) to support Ontario workshop/lecture programs in emerging areas of statistical and data sciences.

Connaught PhDs for Public Impact Fellowship application deadline is January 30, 2025. This competition is open to PhD students in second year or higher at time of application and in good academic standing. This program supports an innovative program of public scholarship – it is less about what your research is and more about how you engage the public about it. Check out previously funded projects. Value: \$12,500.

The <u>Canadian Women's Heart Health Centre</u> has launched its awards program, including heart, brain and vascular health investigator award for senior and ECR investigators **Deadline is January 31, 2025**.

The Social Science and Humanities Research Council next <u>Connection Grant</u> competition is February 1, 2025; U of T researchers will have to meet internal deadlines. <u>SSHRC Insight Development Grants</u> (IDGs) have an application deadline of February 2, 2025. U of T applicants must submit their MRA by 12 noon on Monday, January 27, 2025, with full application online by 9 am, Friday, January 31, 2025. Value: \$7,000 to \$75,000 for 1-2 years. IDGs support research in early stages for emerging (within six years of completion of first doctorate) and established scholars (exploring new research questions and/or approaches distinct from previous/ongoing research).

# DATA SCIENCES

**The U of T Data Sciences Institute Postdoctoral fellowship application deadline is February 7, 2025**. Value: \$63,000 for one year plus up to \$7,000 for benefits and a stipend for knowledge translation activities. The <u>Doctoral student fellowship</u> **application deadline is also February 7, 2025**. Value: \$25,000 per year for up to 3 years. Student research must have a data sciences focus through the development of novel methodology or innovative application of existing approaches.

Crock Wartz Reisman Institute FOR TECHNOLOGY AND SOCIETY 2025 Schwartz Reisman Institute Fellowships application deadline is February 9, 2025. This competition is open to PhD students, although exceptional master's students are encouraged to apply. Value: \$7,500 for one year. The research focus is on technology's role in society, the contemporary needs of human communities, and the systems that govern them.

The <u>SSHRC Partnership Stage 1</u> grant application deadline is February 10, 2025. U of T applicants must meet internal deadlines, submitting roughly a week before the sponsor deadline. Partnership grants support formal partnerships over 4 – 7 years to advance research, research training and/or knowledge mobilization in the social sciences and humanities. Cash and/or in-kind contributions are required.



The Centre for Graduate Professional Development <u>Healthy Research Teams Initiative Seed</u> Funding Grant application deadline is February 28, 2025. This opportunity is open to faculty with graduate faculty membership, librarians, postdoctoral fellows, graduate students in good academic standing and research staff.

Value: \$5,000. Matched funds may strengthen a proposal. This is not primarily a research grant, but proposals that include an original research component may be considered.

The Heart and Stroke Foundation of Canada current funding opportunities include Personnel awards for black scholars and Personnel awards for Indigenous scholars. Application deadline is March 20, 2025, at 4 **pm**. These competitions are open to doctoral and master's students. Value: Up to \$40,000 per year for a maximum of three years.

Molly Towell Perinatal Research Foundation grant application deadline is March 22, 2025. Research projects should support the aims and vision of the Foundation- which is to encourage perinatal research in Canada.


The Triagencies have published guidance on the <u>use of generative AI</u> in the development and review of research proposals.
