The <u>University of Toronto's Provost's Postdoctoral Fellowship</u> **application deadline is April 1, 2025**. Value: up to \$80,000 per year to faculties for up to two years. This competition is open to domestic and international students who identify as Indigenous and/or Black. Interested students should reach out to a prospective supervisor to discuss this opportunity.

NIHR James Lind Alliance Priority Setting Partnerships: The UK's National Institute for Health and Care Research seeks to fund studies addressing the James Lind Alliance (JLA) Priority Setting Partnerships' (PSPs) research priorities. **Next application deadline: April 8, 2025** Learn more **Apply to join the 2025** <u>GROWW</u> **Cohort:** GROWW is a Health Research Training Platform (HRTP) supported by CIHR and IHDCYH. The Cohort program annually accepts a group of 20 clinical trainees, graduate students, postdoctoral fellows, and ECRs from across Canada chosen through a competitive application process. This 1-year training program will include seminars from academics within the field of women's and girl's health, experiential learning opportunities and workshops, mentorship partners, a fall institute, and professional networking to help co-create new research and/or employment opportunities. The <u>Cancer Research Society</u> in collaboration with Ovarian Cancer Canada is offering is the Next Generation Of Scientists Award. **Application deadline is April 22, 2025**. In Part 1 of this competition the postdoctoral fellow must have completed at least two years of postdoctoral training at the time of accepting fellowship. In Part 2 the fellow must obtain a faculty position at a Canadian university or affiliated accredited research centre. Value: the postdoctoral fellowship component is \$50,000 / 1 year; the operating grant component is \$135,000 / 2 years.

The <u>CANStroke Recovery Trials</u> post doctoral fellowship for StrokeGoRed **application deadline is April 23, 2025**. This is a national training competition which will award 2 postdoctoral fellowships valued at up to \$30,000 each.

New CIHR Opportunities

Notice of upcoming funding opportunity: <u>Emerging Learning Health Systems in Mental Health</u> will fund two national learning health systems in early psychosis intervention and perinatal mental health. Objectives: develop a national LHS, enhance access to services to improve quality of life and more. Anticipated timeline: Launch: Spring 2025; application deadline (there may be a registration or expression of interest deadline as well): fall 2025; and funding start date: Winter 2026.

Operating grant: Joint Program On Neurodegenerative Disease Research. <u>Health and social care research</u> with a focus on the moderate and late stages of neurodegenerative diseases. **Pre- proposal deadline March 4, 2025; full proposal due June 24, 2025.** Topics of interest include establishing effective models of care by studying quality of care for example in nursing homes or the effects of prevention or delay of admission to a nursing home; identifying and addressing known barriers for example to improve the accessibility of services etc. unraveling regional differences in the effectiveness and impact of health and social care interventions; and more.
